The debtor and guarantors agree that all transactions are deemed to have occurred within the State of Connecticut and that any disputes by and between Gilbertie's Herb Gardens, Inc. and the debtors are to be resolved within the State of Connecticut and agree to submit to the jurisdiction of the Courts of the State of Connecticut regarding any dispute.

3. The undersigned further agrees in his personal capacity to guaranty unconditionally the proposed payment when due of indebtedness which may at any time be owed to Gilbertie's Herb Gardens, Inc. by the business receiving deliveries hereunder or by any successor thereof. Said guaranty shall be a continuing guarantee and shall remain in force until revoked by the undersigned in writing to Gilbertie's Herb Gardens, Inc. but such revocation shall be only effective as to claims of Gilbertie's Herb Gardens, Inc. arising out of transactions entered into after its receipt of such notice and not as to any transaction and commitment previously undertaken by Gilbertie's Herb Gardens, Inc. in reliance upon this guaranty. This obligation shall cover the renewal of any claims guaranteed by this instrument or extension of time of payment thereof, and shall not be affected by any surrender or release by the corporation of any other security held by it for any claim hereby guaranteed.
